SOCIAL ACTION ALERT ON EL SALVADOR

A recent letter from Rep. Les Aspin, in response to our concern last year about military aid to El Salvador says, in part:

"Although Congress approved the aid, conditions designed to help win a negotiated settlement and protect human rights in E1 Salvador were included in the 1982 Foreign Aid Authorization bill (S. 1196) which was signed by the President December 29, 1981.

As you may know, the administration requested \$26 million in military aid to El Salvador for fiscal 1982 and both the Senate and the House approved this amount. However, the aid is subject to certain conditions being met by the ruling junta....and certified by the president.

The conditions the junta must meet are:
--substantial control over its armed
forces, and

--good faith efforts to begin discussions with all major factions in El Salvador who have shown themselves to be willing to find an 'equitable political solution'--the solution to include a renunciation of military and paramilitary operations.

In providing military aid or arms sales, the President also would have to certify to Congress that El Salvador was making a concerted, significant effort to assure internationally recognized human rights, within 30 days of enactment of the bill and every 180 days thereafter. If he is unable to make the certification, he would have to suspend all U.S. aid and arms shipments, and withdraw all U.S. military advisors from the country.

In addition, the President is required to ensure that the El Salvadoran government has made good faith efforts to investigate the murders of six U.S. citizens in December, 1980, and January, 1981.

Finally, the bill includes lengthy resolutions calling on the government of El Salvador to reform its human rights practices, to seek control of its own armed forces and to continue economic and political reforms. The bill states that economic assistance to El Salvador should emphasize revitalizing its private sector. It also urges the President to set aside a portion of El Salvador's economic aid to provide guarantees to private U.S. banks willing to make loans to private Salvadoran business."

Incredibly, hard on the heels of reports of large-scale killings of civilians by government forces, President Reagan certified on January 28 that the El Salvador government has made an effort to respect human

rights and is in substantial control of its security forces. The Administration is now seeking congressional approval for a massive increase in military aid to the junta--aid that will surely serve to prolong the oppression of the people of El Salvador.

In short, we think we have something to say to our fellow Madisonians, a different way of approaching religious concerns from Jerry Falwell and his ilk, and we decided to say it --publicly and loudly and proudly.

Who are we? We are simply religiouly-committed citizens who got together and thought and finally decided on action. The ad hoc committee is: Rev. Wells Grogan, Rev. Vern Forsberg, Rabbi Kenneth Roseman, Rev. Steven Bremer, Rev. A.C. Schumacher and Rev. Lee Morehead. Also, Gary Aamodt, Avram Weiss, Marjorie Tobias, Midge Miller, J. Mark Thomas, Rev Vern Visick and James Wright.

The first step we are going to take is to sponsor a lecture series (with appropriate opportunities for discussion) which will be open to the community and address major theological and social issues. We call this series AGENDA FOR A PROPHETIC FAITH. The first speaker will be:

February 21 Dr. John Killinger, Presbyteriah minister, Lynchburg Virginia.

All sessions will be held in local religious buildings from 7:00-9:00 p.m.

General topics will include: faith, peace, family life, poverty, and the political process.
