

Inflation Hurts Us All!

It hurts Prairie most because it pinches at both ends—higher costs and lower revenues! Our pledge total to date is no

more that it was five years ago, yet our need for funds is greater due to inflation and the cost of deferred maintenance and repairs. It is extremely urgent that we raise the funds necessary to completely implement our budget. We are not lavish spenders, either. Most societies our size are also supporting a full time minister and other paid staff with a budget more than twice as large as ours! So please, re-examine your pledge, grit your teeth, and give 'til it helps! We need an average increase of 25% in each pledge.

Budget Drastically Cut!

We hope it is only temporary, though. At the December 8 Parish meeting, the membership adopted a significantly scaled back budget. Because of insufficient pledges, all of the following were removed from the budget: UUA support (fair share) - \$3,160; Central Midwest District and North Central Area Council dues - \$960; Stucco repairs - \$3,160; Rain Gutters - \$1,500; Building Manager - \$900; and Directory publication - \$200; a total of \$9,880.

The adopted budget is:

The Board was instructed by the membership to continue fund raising and to attempt to restore the deleted items.

15 Years Ago (1976)

Newsletter editors were Vivian Meyer, followed by Barbara Willard (now James), and then Terri Laurence (now Prudlo) with the help of Mills Miracle (lots of turnover that year...). Joe Hoffman was one of our lay ministers, providing wonderful programs on art. On May 2nd, a potluck supper was given for Joe at the David & Barbara Carson farm prior to his leaving for Berkeley to study for the UU Ministry. Annis Pratt's lay ministry followed Joe's. George and Ruth Calden vacationed in Israel. Barbara Willard argued the case of Dorothy Wetherby's right to bury her daughter Jana Osteraas on farm property before then U.S. District Court Judge James Doyle. A special parish meeting was held in May to resolve problems connected with the Prairie Site. Shirley and John Grindrod became grandparents of Elijah Daniel. Lilo Koehl left Madison for points West. Mike & Norma Briggs did the final lay ministry of '76.

10 years ago (1981)

John and Shirley Grindrod began the lay ministries of '81, followed by Peg Stevenson and Dave Zakem. Aileen Nettleton was President of Prairie. David Lisman, Judy Spring and Shirley Lake taught "Why Do Bad Things Happen" to RE grades 3-5. Mike Briggs offered a tax workshop and Doleta

Chapru taught dancing to benefit Prairie. The Briggs also donated a piano to the RE program. Metje Butler and Avis Parrish volunteered to coordinate the first Prairie Cookbook. Alice and Lee Bullen were official delegates to the UU General Assembly in Philadelphia.

5 years ago (1986)

Rick Ruecking was President of Prairie. Leslie Watkins donated a large stock of Paperteria merchandise for Prairie sale and service auction. Dick Bonser took over the editorship of Prairie Fire from Lee and Alice Bullen. Prairie collected \$227 from our 'Guest at Your Table' program. Prairie's adopted budget for 1986 was \$23,653 (we've come a long way, baby...). Brent and Dayle Haglund hosted a farewell party for Gail Ostler, who left Prairie for a job in Milwaukee, and Mary Mullen and Fredericka hosted a farewell for RE Director Mary Beth O'Halloran and Elizabeth Jones. We lost two beloved members—Lois Hagstrom and Les Lyons. The Play-readers have a theater trip to see Extremities. In Pat Watkins' Sunday service on volunteerism, we learned that Prairie folk spent about 600 hours a month doing volunteer work for more than 53 organizations. We toured the International Crane Foundation followed by a potluck picnic. Metje Butler won "Best of Show" at Madison Art Guild's juried salon. "The Gospel According to Woody Allen" was lay minister George Calden's first program.

May all of you, and Prairie also, prosper in the New Year.

[The problem with the taffy was an error in the recipe. It called for

cooking the candy "to the brittle stage of 256°" instead of to "the soft ball stage of 234°-238°" as another pulled-candy recipe said. The recommended "heavy pan" meant aluminum or stainless steel, not the cast iron that we used, which kept the candy hotter longer after it was removed from the heat. -Metje Butler]
